Founder and Executive Director of the World Association of Marching Show Bands. He is internationally recognised as a music educator, adjudicator and director. His band has won major awards around the world, in North America, Japan and Europe. He directed the bands during the Open Ceremonies and the Awards Ceremonies of the 1988 Winter Olympics. He was President of the Alberta Band Association and the Canadian Band Association. He has served two terms as Chairman of the North American Band Director's Coordinating Council.

He also studied at the Escola de Música da Orquestra Sinfônica de Porto Alegre, the Instituto dos Meninos Cantores de Novo Hamburgo and the Fundação de Arte de Montenegro. He specialized in composition, arranging and conducting. He is a post-graduate in Contemporaneous History from the Faculdade Porto Alegrense de Ciências e Letras. He has devoted the last twenty years to working in the formation and improvement of bands in the Rio Grande do Sul.

He is also Director of Bands at the Mahidol University School of Music, conducting their Wind Ensemble and Symphonic Band. Mr. Brattin received his B.M. in Tuba and Bass Trombone Performance in 1987, and M.M. with double emphasis in Wind Conducting and Tuba Performance in 2002, both from the University of Northern Colorado. He was the Band Director of the multi-award-winning Taipei Municipal Chien Kuo, Chung Shan Girls, and Ching Mei Girls High Schools, and starting in September of 2003, Mr. Brattin will be the new Director of Bands at Northglenn High School, in Northglenn, Colorado, in the United States. He is a member of the WAMSB Advisory Council.



### Genkichi Harada – Japan

Genkichi Harada has been the Executive Director of the Japan Marching Band Director's Association since it's founding in 1969. Mr. Harada is a member of the NHK Symphony Orchestra. Henk Smit is the Managing Director of UNISONO Netherlands and Director of Concordia Middlestum, Mr. Smit is also a supervising judge of the marching and show competitions of the World Music Competitions in the Netherlands. He is a WAMSB advisory council member and is actively involved as a clinician and judge with bands throughout Europe.



### Nipatdh Kanchanahuta - Thailand

Nipatdh Kanchanahuta graduated from Department of Music, the Faculty of Fine and Applied Arts Chulalongkom University with Honours and completed a Master Degree in the development of Marching Bands from the University of Texas. He was appointed horn player with the Bangkok Symphony Orchestra for a period of seven years and performed with many famous conductors.
